(Conversion of Single Cabin Hilux into 4 Door-Double Cabin through Framework Contract)

The Punjab Healthcare Commission (PHC) is an independent regulatory authority, established under the PHC Act, 2010. The Commission invites sealed bids/proposals for Repair & Maintenance of eight (08) single cabin Hilux vehicles which includes conversion of Single Cabin Hilux into 4 Door-Double Cabin, **through Framework Contract** from eligible firms/contractors, registered with Sales Tax and Income Tax Departments.

4. Bids shall be opened on **02-06-2020 at 11:30 AM**, in the office Conference Room of Punjab Healthcare Commission, in the presence of the bidders or their authorized representatives, who choose to be present.

6. Incomplete, conditional and bids without appropriate bid security shall not be considered.
